## **Cardmember Agreement**

**Important**: Before you sign or use the enclosed Card from Nations Trust Bank PLC, please read the Cardmember agreement carefully. By accepting and/or signing and/or using the Card, you accept the terms and conditions set out below and will be bound by them.

#### 1.Definitions:

- a) Applicant means any person who has signed the Card application form.
- b) Bank means Nations Trust Bank PLC, its successors and assignees.
- c) Basic Cardmember means a cardmember in whose name the Bank has opened or decided to open a Card account.
- d) Card means American Express Gold, Green, Blue or any other American Express branded Charge or Card issued by the Bank.
- e) Card Account means the Card account opened by the Bank for the purpose of entering all credits and debits received or incurred by the basic Cardmember and the supplementary Cardmember(s), if any, under this agreement.
- f) Cash Advance means an act of obtaining money by the use of the Card, the Card number or the PIN.
- g) Cash Advance Limit means the maximum limit permitted by the Bank for cash advances.
- h) Cardmember means an applicant to whom a Card is issued by the Bank.
- i) Charge or Transaction means any transaction made or charged with the Card including applicable fees levied and all other amounts which the Cardmember agrees/has agreed to pay the Bank or agrees/has agreed to be liable for, under this agreement.
- j) Credit Limit means the maximum outstanding debit balance permitted by the Bank on the Card account.
- k) Current Balance means the total amount outstanding on the Card account as at a particular date.
- 1) Minimum Payment Due is the amount specified on the statement as minimum amount payable by the payment due date.
- m) Past Due is the cumulative minimum payment due (if any) outstanding from previous statement(s). Any past due is shown separately on the statement, and is payable immediately.
- n) Total Minimum Payment Due is the total of the minimum payment due and the past due. This is shown separately on the statement.
- o) Total Outstanding means the total debit balance (inclusive of all charges which shall be debited to the Card account) outstanding on the Card account payable to the Bank according to the Bank's records on the date the statement is issued.
- p) Payment Due Date means the date specified on the statement as the date by which, payment of the total outstanding or any part thereof or the minimum payment due is to be made to the Bank.
- q) Transaction Date means the date on which a transaction between a Cardmember and a service establishment takes place.
- r) Post Date means the date on which a transaction is processed and transferred to the Cardmember account.

- s) Overseas Transactions means transactions done overseas.
- t) Service Establishments means establishments, wherever located, which honour the Card or are willing to accept the Card as a payment instrument for purchase of goods and services.
- u) Statement means a monthly statement of account(s) sent by the Bank to a Cardmember setting out the financial liabilities on that date of the basic Cardmember and any supplementary Cardmember(s) to the Bank in respect of the Card account.
- v) Supplementary Cardmember means an individual other than the basic Cardmember to whom a Card is issued at the request of the basic Cardmember and whose charges are chargeable to the basic Cardmember's Card account.
- w) PIN means the personal identification number given by the Bank or chosen by the Cardmember for use with the Card through automated teller machines (ATM).
- x) T-PIN means the telephone personal identification number given by the Bank or chosen by the Cardmember for identification purpose with the Bank, over the telephone. This facility will be made available at the discretion of the Bank
- y) Third Party Service Provider means a third party with which the Bank may liaise with to provide extended benefits and/or services through the Card.

## 2. Applicability of Terms & Conditions and Statutory Compliance:

- 2.1 All facilities made available by the Bank to any person in respect of the Card or Card account are subject to the terms and conditions set forth in this agreement, and to the terms and conditions and stipulations contained in any other programme which is in force from time to time, of which the Cardmember conclusively evidences his acceptance by his/ her signature on the application form for the Card, and/or, by his/her signature on the Card or on making use of the Card.
- Use of the Card must be in strict accordance with all the applicable laws, relevant exchange control regulations of Sri Lanka, and any policies and regulations as applicable and as amended from time to time.
- 2.3 Cardmembers shall not use the Card(s) to purchase / import goods in commercial quantities or for capital transactions.
- 2.4 In the event, use of the Card necessitates Electronic Fund Transfer (EFT) or withdrawal from ATMs in a foreign currency, it will be subject to the regulations issued by the Department of Exchange Control from time to time and will be for authorized purposes only.
- 2.5 The Bank will comply with the requirements of the controller of exchange or any other regulatory authority as stipulated from time to time and will disclose such transactions to relevant authorities under prevailing rules and regulations of the Democratic Socialist Republic of Sri Lanka.
- 2.6 The Bank may, on its own accord, cancel the Card (s) without notice to the Cardmember(s) in the event that the Bank has any reason whatsoever to believe that there has been a violation of the exchange control regulations or any other statutory regulations in force at the time of such cancellation.

## 3. Card Services:

The Card is not transferable and the usage is subject to the terms and conditions of this agreement and any additional conditions as stipulated by the Bank from time to time. The Cardmember shall sign on the reverse of the Card immediately on receipt, and the signature on the Card shall be identical to the one contained on the application form.

## 4 Delivery of the Card:

Cards will be couriered, sent through registered post or collected over the counter by the Cardmember, the supplementary Cardmember(s), or an authorized third party. When the basic Cardmember and any supplementary Cardmember receive the Card(s) he/she should produce proof of his/her identity and acknowledge receipt immediately by duly signing the acknowledgement slip provided. The Cardmember at his/her discretion may authorize a third party in writing to accept or collect the Card(s) on his/her behalf and will be liable for all charges incurred on the Card from the time the Card is accepted by the Cardmember or the person authorized on his/ her behalf. The Bank may at its discretion hand over the Card to a third party determined by the Bank or its representative to be the representative of the Cardmember. The Cardmember shall be liable for all charges on the Card from the time the Card is so delivered.

## 5 Use of the Card:

- 5.1 The Card is valid worldwide; however, the Bank and the service establishments concerned reserve the right, at any time, to refuse the use of the Card at a service establishment for any reason whatsoever. The Card may be used only for bona fide personal or official purposes and its use is not permitted to be exploited commercially in the business of the Cardmember. It is clarified that Charges incurred, may in case of some service establishments, include a charge for availing of the purchase or other facility.
- 5.2 The Cardmember shall at all times keep his PIN and T-PIN confidential and separate from the Card, and also shall ensure that the Card is kept in a safe place and is not used by any other individual. The Cardmember shall be fully liable for all transactions made with the PIN and T-PIN, whether with or without the knowledge of the Cardmember.
- 5.3 Upon use of the Card at a service establishment, the Cardmember must collect the copy of the charge slip at the time of signing the charge slip. Normally, the Bank shall not provide copies of other charge slips to the Cardmember. However, at the sole discretion of the Bank, copies may be provided on payment of additional fees as determined by the Bank.
- The Cardmember accepts that the Bank may selectively agree to provide him with the facility of effecting mail order or telephone order purchases or transactions through internet, and in such cases, the charge slips will not be signed by the Cardmember at the time of Card utilization. Accordingly, the Cardmember accepts that, even in the event of any dispute regarding the authenticity or validity of such a purchase or a charge, for any reason whatsoever, the Cardmember will settle the outstandings. Any such dispute shall be a matter between and will be settled by the Cardmember and the concerned service establishment. The Bank shall not be liable, in any manner whatsoever, for the same.
- 5.5 The Card may only be used within the credit limit notified by the Bank to the Cardmember and on or prior to the last date of the month embossed on its face.
- The Cardmember agrees that he/she has made a standing request that, subject to the sole discretion of the Bank, renewal and/or replacement Cards be issued to each Cardmember until such time the Bank is notified in writing by the Cardmember. The Bank reserves the sole right of renewing the Card facility on expiry, loss, damage, or theft of the Card. In the event of such non-renewal, the Cardmember shall immediately settle the balance due to the Bank without demur or delay.

- 5.7 The Cardmember undertakes to act in good faith at all times in relation to all dealings with the Card(s) and the Bank.
- The Bank reserves unto itself the absolute discretion and liberty to suspend or reduce the credit limit, decline or honour an authorization request on the Card at any point of time without assigning any reason whatsoever. The Bank shall not be liable for any consequence arising out of any loss/damage suffered by the Cardmember on account of such suspension, decline or reduction in the credit limit of the Card.

#### 6 Breach:

In the event of any breach of this agreement by any Cardmember:

- 6.1 Notwithstanding any other provision of this agreement, the Cardmember will indemnify the Bank for any loss to the Bank directly or indirectly resulting from such a breach.
- 6.2 The Cardmember will be liable to pay the Bank, upon demand, all outstanding amounts from the Cardmember to the bank, whether due and payable to the Bank at the date of such demand or not.

## 7 Termination:

- 7.1 The Cardmember may at any point of time request termination of the Card facility, by providing a written notice to the Bank.
- 7.2 Upon providing a written notice to the Bank, it is mandatory for the Cardmember to cut the Card into four pieces, ensuring that the magnetic strip has been cut and the card is destroyed securely by the Cardmember.
- 7.3 Save as aforesaid, the Cardmember may not terminate any Card or Card account.
- 7.4 In the event charges are incurred on the Card after the Cardmember claims to have destroyed the Card, the Cardmember shall be entirely liable for such charges, whether or not the same are the result of the misuse and whether or not the Bank has been intimated. The Bank may at any time, with or without notice, as to the circumstances in the Bank's absolute discretion require, terminate the Card.
- 7.5 On termination of the Card and notwithstanding any prioragreement between the Bank and the Cardmember to the contrary:
  - i The Cardmember's right to use the Card will immediatelycease; and
  - The total of all charges then outstanding, whether or notalready reflected on the statement, as well as the amount of any charges incurred after termination (with effect from the date of relevant transaction instruction), shall become for thwith due and payable by the Cardmember as though they had been so reflected, and interest will accrue thereonas applicable.
- 7.6 The whole of the outstanding balance of the card accounttogether with the amount of any outstanding Cardtransactions effected but not yet charged to the Cardaccount will become immediately due and payablein full to the bank on termination of this agreement or on the Cardmember's bankruptcy or death. The Cardmember or his estate will be responsible forsettling any outstanding on the Card account and shallkeep the Bank indemnified against all costs, charges (including legal fees) and expenses incurred in recoveringsuch outstanding. Pending such repayment, the Bank will beentitled to continue to charge finance charges and other feesand charges at its prevailing rate(s).
- 7.7 Notwithstanding the termination of this agreement by either party, the Cardmember shall continue to be liable for allfurther charges incurred by the use of the Card.

#### 8 Card to be Used Overseas:

The Card is valid internationally at service establishments and if itsusage exceeds the entitlements as per the guidelines of the CentralBank of Sri Lanka (CBSL), then the Cardmember undertakes to obtain the requisite permission from CBSL by complying with CBSLrequirements. However, under no circumstances should repayment of the statement be delayed or refused on the grounds of excessdrawing.

# 9 Cardmember Proceeding Abroad:

A Cardmember migrating and/ or proceeding abroad on permanentemployment, or who is deemed "non-resident" as per definitions of exchange control regulations in force at that time must inform the Bank in writing, and must settle all billed and unbilled charges and must also surrender the basic Card and any supplementary Cards.

# 10 Card to Non-Resident Sri Lankans (NRSL):

NRSL are not permitted to hold Cards as per the prevailing guidelinesissued by the CBSL. In such an instance, the Cardmember must return the basic Card and any supplementary Card(s) to the Bank.

## 11 Cards to Foreign Nationals:

A foreign national Cardmember may use the Card if he/she residesin Sri Lanka. Such foreign national Cardmembers should inform the Bank in writing, one month prior if he/she is leaving the countrypermanently, and/or one month prior to the expiration of his residentvisa. He/she should settle the billed and unbilled charges in full and surrender the Card(s) to the Bank before either of the aforesaidevents occurs.

## 12 Charges in Foreign Currency:

Transactions which are effected in currencies other than Sri LankanRupees will be debited to the Card account after conversion into SriLankan Rupees at an exchange rate determined by the Bank.

12.1 The Bank will convert all foreign currency transactions into the billing currency, using the prevailing USD / LKR exchangerate maintained by the Bank. In the case of transactions inforeign currencies other than USD, the transaction will beconverted into US Dollars by American Express before being converted to the billing currency. In respect of all foreign currency transactions a conversion factor as decided by the bank will beadded to the converted amount.

#### 13 Cash Advances:

13.1 Cash advances obtained by Cardmember(s) from automated teller machines (ATMs) or Bank branches or cash disbursingmerchants or agents will be subject to ATM, bank, merchant, agent, local or country limits and restrictions. Central Bankand Exchange Control Department regulations will also apply. The

Cardmember will not be able to obtain Cash advancesfrom ATMs with the Card unless he uses the PIN issued by theBank.

- 13.2 Cardmembers can obtain Cash advances up to the cashadvance limit. Temporary credit limit enhancements and/or cash deposits or fund transfers to Card accounts will not in any way increase the cash advance limit.
- 13.3 This facility may be changed or withdrawn by the Bankwithout prior notice to the Cardmember.

## 14 Credit Limit:

The cover letter accompanying the Card, as well as the statement, will show the initial credit limit applicable to the Cardmember's account. The Bank will determine the credit limit and notify the same to the Cardmember from time to time. If the current balance exceeds the credit limit, the Cardmember must make immediate payment of anyexcess. An over limit charge will be levied to the Card account asmay be applicable from time to time if the credit limit is exceeded irrespective of the amount by which the credit limit is exceeded.

# 15 Expiry of Cards:

The Card will be valid until the expiration date printed on its face. Renewal of the validity of the Card shall be as provided in Clause 5.6.

## 16 The Card Remains Property of the Bank:

The Card remains the property of the Bank, which can revoke theright of the basic Cardmember or any supplementary Cardmember use it at any time. The Bank may exercise this right with or without giving notice to the Cardmember and with or without cause. The Bankmay list revoked Cards in "Cancellation Bulletin" or otherwise informservice establishments that the Card has been revoked or cancelled, If the Bank revokes the Card, the Cardmember must return it to theBank. Also, if a service establishment asks a Cardmember to surrender an expired or revoked Card, the Cardmember must do so. The Cardmember must not use the Card after it has expired or after it has been revoked. The Cardmember shall continue to be liable for allcharges incurred after revocation or expiry of the Card.

The revocation, repossession or request for the return of the Card is not, and shall not constitute any reflection on the Cardmember's character or creditworthiness and the Bank shall not be liable in any way for any statement made by any person requesting the return or surrender of the Card.

Furthermore, privileges and facilities attached to the Card maybe withdrawn at any time at the absolute discretion of the Bankwithout giving any notice to the Cardmember or assigning any reasonthereof.

## 17 Charges:

- 17.1 The Cardmember agrees to pay to the Bank upon the requestof the Bank, a joining fee as prescribed by the Bank for the Card when issued, and a joining fee prescribed by the Bankfor each supplementary Card when issued.
- 17.2 Annual fees are payable for use of the Card and shall be billedin advance at such rates as the Bank communicates to the Cardmember.

- 17.3 When the Card is couriered to an overseas address, the Bankwill debit a handling fee to the Card account.
- 17.4 A handling fee for limit increases will be debited to the Cardaccount.
- 17.5 A handling fee for copies of statements would be debited to the Card account.
- 17.6 If the Cardmember does not settle the total outstanding by the payment due date, the total outstanding balance on the statement Date, will attract a finance charge calculated on the daily balance over the Billing Period at a rate to be determined by the Bank. The finance charge is debited to the Card Account on the subsequent Statement Date.
- 17.7 Without prejudice to the payment of the finance chargereferred to in Section 17.6 above, if the Cardmember fails to pay the minimum payment due / total minimum payment due by the payment due date, a late payment fee will be charged and debited to the Card account at a rate to be determined by the Bank.
- 17.8 The Bank shall charge the Cardmember and debit the Card account a handling fee at a rate to be determined by the Bank, if any cheque or other payment order issued or presented by the Cardmember or any other party to the Bank is not honoured for any reason whatsoever. This charge will be in addition to any postage charges that may be charged by the Bank.
- 17.9 A Cash advance fee and/or a handling fee will be charged onall Cash advances and debited to the Card account at a rate to be determined by the Bank. Any instrument purchased on the Card which are readily convertible to cash such as travellers cheques, demand drafts, telegraphic transfers, etc.will also be treated as Cash advances and will be subject to the above charge.
- 17.10 An over limit fee will be charged and debited to the Card account, if the assigned credit limit is exceeded at any pointin the billing period. It is levied once per billing period. Forthe purpose of computing, whether the credit limit has been exceeded or not, the amount of any bank charges will also beconsidered.
- 17.11 Purchases of petrol, diesel, gas and other supplies available from petrol stations in Sri Lanka, are subject to a handling fee, which will be debited to the Card account at a rate to be determined by the Bank.
- 17.12 A retrieval fee for the photocopy of sales/cash advancedrafts will be debited to the Card account at a rate to bedetermined by the Bank.
- 17.13 Any statutory charge(s) which may be applicable from time to time will be charged to the Cardmember's Card account as and when it/they become applicable.
- 17.14 Details of the finance charges and other fees and chargesapplicable to the Card and its use are stated on www.nationstrust.com / <a href="www.americanexpress.lk">www.americanexpress.lk</a>. All charges, fees, interest rates, fines and margins are subject to change at the Bank's sole discretion without notice to the Cardmember and any such changes/additions to the tariff will be communicated to the Cardmembers by way of a narrative in or enclosed with the statement or by SMS or email notification.
- 17.15 The Bank reserves the right to charge a fee for any extraservice carried out at the request of a Cardmember and to debit the Card account with such fee.
- 17.16 Any fee reductions or waivers that may be offered by theBank from time to time may be withdrawn or restricted bythe Bank at any time at its discretion. The Bank at its owndiscretion may exempt some of the charges depending on the Card type and the circumstances.

## 18 Transactions with Airlines:

When an air ticket is booked using a Card, the Cardmember will have to pay for the purchase of tickets subject to any additional charges, if applicable, and the same shall be billed in the statement. For any ticket subsequently cancelled, the amount will be credited to the Card account (less cancellation charges) as and when credit for the same is received by the Bank from the service establishment.

# 19 Disputes:

Any charge or other payment requisition received from a service establishment by the Bank for payment shall be conclusive proof thatthe charge recorded on such requisition was properly incurred at theservice establishment in the amount and by the Cardmember referred to in that charge or other requisition, as the case may be, by the useof the Card except where the Card has been lost, stolen and properlyinformed to the Bank as per Sections 27.1 and 27.2. The burden of proving fraudulent use of the Card shall be on the Cardmember. The other payment requisition referred to in this clause shall include any and all payments pertaining to permissible expenses incurred by a Cardmember at a service establishment by use of the Card which is not recorded as a charge, such as miscellaneous hotel charges etc. Signature of the Cardmember on such charge, slip together with the Card number noted thereon shall be conclusive evidence as between the Bank and the Cardmember as to the extent of liability incurred by the Cardmember and the Bank shall not be required to ensure that the Cardmember has duly received the goods purchased/to be purchased or has duly received the service availed or to be availed to the Cardmember's satisfaction. Should the Cardmember disagree with a charge indicated onthe statement, the same should be communicated to reach the Bank within 20 days of receipt of the statement, failing which, it would be construed that all charges and statements are entirely in order. Authority to charge Cardmember's account in respect of charge made/to be made, services availed/ to be availed would be given by the Cardmember either in the form of a charge slip as used at the service establishment and provided by the Bank or such other form as may be prescribed by the Bank. The Bank shallmake bona fide and commercially reasonable efforts to resolve an aggrieved Cardmember's disagreement with the applicable charge indicated on thesestatements on receipt of the notice of disagreement. If after such effort, upon Bank determines that the charge indicated on the statement is correct, then it shall communicate the same to the Cardmember along with details including a copy of the charge slip or payment requisition. The Cardmember shall thereafter without demur make payment, including interest and any other applicable charges. The Cardmember will be liable for any exchange loss, which may result from the cancellation, reversal or refund of a transaction including refunds or reversals due to disputed transactions.

## 20 Dishonour of the Card:

The Bank gives no guarantee that the Card will be honoured by any particular service establishment and accepts no responsibility forrefusal by any service establishment to honour the Card.

## 21 Change of Name and Address:

The Cardmember must inform the Bank of any change in name oraddress, by writing to the Bank's Card Centre.

#### 22 Quality of Goods and Services:

The Bank shall not in any way be responsible for merchandise, warranty or services purchased or availed by the Cardmember from service establishments including on account of delay in delivery, non-delivery, and non-receipt of goods or receipt of defective goods from mail order placed by the Cardmember. It must be distinctly understood that the Card facility is purely a facility to the Cardmember to purchase goods or avail of services and the Bank holds no

warranty or makes no representation about quality, quantity, delivery or otherwise howsoever regarding the goods or services, and the Cardmember with the service establishment must resolve any dispute. The existence of a dispute shall not relieve the Cardmember and he/she agrees to pay promptly such charges, notwithstanding any pending dispute or claim whatsoever.

#### 23 Insurance Protection for Cardmembers:

The Bank may, in its discretion, provide a Cardmember with various insurance products from time to time. However, any claims on suchinsurance must be made directly to the insurance company providingsuch insurance. The Bank will not be responsible for any non-paymentor dispute that may arise from such insurance and any such issues must be settled between the Cardmember and the insurance company. All applicable insurance will be intimated by the Bank from time totime, which may be amended or modified at the discretion of theBank. Separate terms and conditions as determined by the insurance company shall apply for various insurance policies. Policies withterms and conditions shall be forwarded on request.

## 24 Minimum Payment Due:

The statement will show the minimum payment due. The amount willbe determined by the Bank from time to time, which will be calculated as a percentage of the outstanding balance on the statement or a flat charge rate (whichever is higher). The minimum payment due isdue and payable by the Cardmember to the Bank on or before thepayment due date. Payment takes place only when the Bank receives and credits the same to the Cardmember's account, and not when the Cardmember dispatches it.

The Cardmember will be required to pay the Bank immediately if the Card account is overdue or the credit limit is exceeded, and the samewill be notified on the statement. The payment by the Cardmember the Bank may be more than the minimum payment due, or may be made before the payment due date, or more than once during the billing period. Such payments to the Bank must be made in Sri Lankan Rupees in the manner indicated on the statement.

## 25 Exclusion of Liability:

The Bank shall be under no liability whatsoever to the Cardmember in respect of any loss or damage arising directly or indirectly out of:

- a) Any defects in any goods or services supplied;
- b) The refusal of any person to honour or accept a Card;
- c) The malfunctioning of any computer terminal and/or EDCmachine;
- d) The giving of transaction instruction other than by cardmember;
- e) Any statement made by any person requesting the return of the Card or any act performed by any person in conjunction with such a request;
- f) Handing over of the Card by the Cardmember to any person other than designated employees of the Bank;
- g) The exercise by the Bank of its rights to demand and procurethe surrender of the Card prior to the expiry date embossed on the face of the Card, whether such demand and surrenderis made and/or procured directly by the Bank or through aservice establishment or an agent of the Bank;

- h) The exercise by the Bank of its right to terminate any Card or Card account;
- i) Any injury to the credit character and reputation of an applicant or Cardmember alleged to have been caused by therepossession of the Card and/or any request for its return orthe refusal of any service establishment to honour or accept the Card;
- j) Any mis-statement, misrepresentation, error or omission inany details disclosed by the Bank pursuant of Section 26:
- k) Decline of a charge for any reason whatsoever;
- l) In the event a demand or claim for settlement of outstanding dues from the Cardmember is made either by the Bank or any person acting on behalf of the Bank, the Cardmember agrees and acknowledges that such demand or claim shall not be deemed an act of defamation or an act prejudicial toor reflecting upon the character of the Cardmember, in any manner;
- m) The communications and arrangements for various services are provided by a third party service provider and/or contractors of such third party service provider and are paid for by either such third party service provider or by the Bank. The Cardmember is responsible for the cost of any and all such services used. Assistance is provided on a best effortbasis and may not be available due to problems of time, distance or locations. The insurance, medical and/or legalprofessionals suggested and/or designated by third partyservice providers are not their employees or employees ofcontractors of third party service providers. Therefore, theyare not responsible for the availability, use, acts, omission, orresults of any insurance, medical, legal or any other services. The Bank does not accept any responsibility or liability ofwhatsoever nature for the arrangement or use of servicesprovided.

#### 26 Disclosure of Information:

Subject as hereinafter provided in this Section 26, the Bank shallpreserve the confidentiality of all details of transactions or dealing between the Cardmember and the Bank to the extent required by thegeneral law. Notwithstanding the foregoing, the Cardmember hereby authorizes the Bank to provide information about the Cardmember and/or the Card account to:

- a) Any bank or financial institution, or credit bureau or commonservice provider who manages a credit bureau or database ofdefaulting customers;
- b) Any actual or proposed assignee of the Bank or participantor sub participant in or transferee of any of the Bank's rightsin relation to this agreement or the Card account;
- c) Any agent, contractor or service provider under a duty of confidentiality to the Bank or to any related company;
- d) Any supervisory or regulatory authority;
- e) Anyone when ordered to do so in accordance with the lawsof Sri Lanka;
- f) Any office or branch of any company associated with the Bank for commercial use; or
- g) The American Express Company or any of its affiliated companies.

# 27 Lost Card Liability:

- 27.1 If a Card is lost or stolen, the Cardmember must immediately inform the Bank's Card Centre in Sri Lanka. The Cardmember must also file a report with the local police/law enforcementagency where the loss/theft occurred. The Cardmember will be liable for charges incurred on the Card until the Bank's Card Centre in Sri Lanka is notified of the loss.
  - A Cardmember may report a Card lost over the telephone, duly supported thereafter by sending to the Bank's Card Centre a copy of the notarized affidavit confirming loss of the card and disclaiming the charges, if any, and also sending tothe Bank signed copy of the report lodged with the local policeauthorities/law enforcement agencies where the loss occurred. The Bank may, upon adequate verification, temporarily suspendthe Card account and will not be liable for any inconvenience caused to the Cardmember on this account. The Cardmember shall be liable for all amounts debited to the Card account and pending transactions yet to be debited to the Card account, as a result of the unauthorized use of the Card until effective notification is given to the Bank's Card Centre in Sri Lanka. Oncea Card is reported lost, stolen or damaged, the Card shouldnot be used again even if found subsequently, unless the Bank has provided clearance to use the same Card. In the event Cardmember uses the Card without clearance from the Bank, such transactions may get dishonored. The Cardmember declares that if a Card is reported lost, stolen or damaged and is subsequently found and the Bank confirms that the same card cannot be reactivated the Cardmember shall be solely responsible forcutting the Card in to four pieces as specified in Clause 7.2. The Cardmember is responsible for the security of the Cardat all times and shall take all steps towards ensuring the same. In the event the Bank determines that the aforementioned steps are questionable, Bank may cancel the Card account.
- 27.2 The Cardmember will give the Bank all the information in the Cardmember's possession as to the circumstances of theloss, theft or misuse of the Card and take all steps deemednecessary by the Bank to assist in the recovery of the missing Card.
- With regard to lost Cards, the Bank will levy a charge to coverthe administrative costs in informing the merchant network.
- 27.4 The Bank will be under no obligation to issue a replacement Card to the Cardmember following its loss or theft. Anyreplacement Card will be subject to a handling fee which willbe debited to the Card account at a rate to be determined bythe Bank and shall be issued where the Bank so determines on the same terms and conditions as the original Card.
- 27.5 In the event the PIN and/or T-PIN is lost, stolen or disclosed any other party, the Cardmember shall immediately notify such loss or disclosure together with the particulars thereof the Bank as in Sections 27.1 and 27.2.

## 28 Payment:

- 28.1 The Cardmember shall pay to the Bank upon receipt of the statement, at least the "Total Minimum Payment Due "amount described in the statement. Each supplementary Cardmember is liable jointly and severally with the basic Cardmember, to pay the Bank the total minimum payment due upon receipt of the statement by the Cardmember.
- 28.2 The Cardmember hereby irrevocably authorizes the Bank to without any notice to the Cardmember debit any of the current accounts or savings accounts or uplift and debit fixed deposit accounts maintained by the Cardmember at the Bank at the sole discretion of the Bank with all overdue amounts payable under or in respect of the Card on the due dates as agreed above, together with the amount of interest payable.
- 28.3 Nothing in these terms and conditions shall affect theBank's right of set off, transfer and application of monies atlaw or pursuant to any other agreement from time to time

subsisting between the Bank and the Cardmember. Where Card accounts have been opened against a deposit held under lien to the Bank, the proceeds of thesaid deposit will be adjusted against the outstanding in the Cardaccount without notice to the Cardmember in the event thepayments referred to herein are in arrears / due.

- 28.4 Payments to the Bank in respect of the liabilities of the Cardmember shall be deemed not to have been made until such time as the relevant cleared funds have been received by the Bank.
- All amounts due to the Bank under these terms and conditions shall be payable without any deduction whatsoever by wayof set off or counter-claim or otherwise of any amount due or alleged to be due or outstanding from the Bank orany other person and notwithstanding any legal intimation, disability or incapacity of any Cardmember. The Bank shall have general lien on all the assets / monies / deposits /securities belonging to the Cardmember and which are in orunder the possession, control or power of the Bank.
- Any credit given in respect of the supply of goods and/orservices will be applied by the Bank to the Card accountonly after receipt by the Bank's Card Centre of notification a form acceptable to the Bank and in accordance withthe prevailing American Express terms and conditions asapplicable.
- 28.7 In the event that a cheque representing payment is returned by the drawee Bank for any reason, the Cardmember shall be liable for criminal proceedings which may be applicable under law.
- 28.8 The entire outstanding dues in the Card account shallbecome payable in full by the Cardmember, his successors or assignees, in the event of death, insolvency or winding upof business of the Cardmember. In the event that repaymentliability is borne by a Cardmember's employer and in the event that such employer's business is wound up or becomes bankrupt or is declared insolvent for any reason whatsoever, and/or is unable to make such payment, the Cardmember shall be held personally liable for the settlement of all dues to the complete satisfaction of the Bank.
- Non-receipt of the statement shall not be construed by the Cardmember to be sufficient reason for timely non-payment of charges. In the event of non-receipt of the statement forany reason whatsoever, the Cardmember undertakes to call the Bank to request his/her latest balance and/or duplicatecopy of statement, and to pay the Bank the sum total of allcharges applicable.
- 28.10 A cheque deposit shall be acceptable for collection and the proceeds shall not be available until the cheque has been cleared and the proceeds paid to the Bank by the payingbank. Any cash deposits may only be regarded as having been received by the Bank upon crediting the same to the Card account.
- 28.11 The Cardmember may issue a direct debit standing instruction to the Cardmember's current or savings account with theBank, to make payments of a percentage of the Cardmember's outstanding Card bill amount to the Card account on thepayment due date.
- 28.12 The Cardmember agrees that any amendments and cancellation to any such standing instruction should reach the Bank at least two weeks before the next payment due date.
- 28.13 For a direct debit standing instruction given to a settlementaccount with the Bank, the following additional terms and conditions apply.
  - a) The Cardmember agrees that the Bank reserves the rightto determine the priority of any such standing instruction against cheques presented or any other arrangements madewith the Bank.
  - b) The Cardmember agrees to provide sufficient funds in the designated settlement account in order to meet the standing instruction, on the day prior to the payment due date. In case of insufficient balance in the settlement account, the Bank atits discretion may grant overdrafts from time to time to cover

the payment amount as per the standing instructions. The Cardmember is bound to repay on demand all outstandingamounts together with the finance charge accrued thereon, at a rate to be determined by the Bank from time to time.

- 28.14 The Bank may at any time demand that the Cardmember deposits an undated cheque and/or pledge cash collateral in favour of the Bank for the amount, which the Bank may require even when such a cheque or cash collateral was not demanded when the Card was issued to the Cardmember. The Cardmember, in such an event, will be deemed to have authorized the Bank to insert the date on the said cheque and to present it for payment on the inserted date against any amount due to the Bank.
- 28.15 The Cardmember expressly accepts that if the Cardmember fails to pay any monies when due or which may be declared due prior to the date when they would otherwise have become due or commits any other default under any agreement with the Bank under which the Cardmember is enjoying any financial/credit/other facility, then in such event, the Bank shall without prejudice to any of its specific rights under each agreement or this agreement, be absolutely entitled to exercise all or any of its rights as set out in this agreement at the sole discretion of the Bank.
- 28.16 The Bank reserves the right to assign dues from any Cardmembers to its authorized collection agency to collectthe amount outstanding and the Bank shall be entitled to charge to the Cardmember account with the expenses it hasincurred in doing so.
- 28.17 In case any payment instrument forwarded by or on behalf of the Cardmember is not honoured, the Bank reserves the rightto proceed legally against the Cardmember and would at its discretion levy penal fees and/or cancel the Card account.
- 28.18 Without prejudice to the other provisions of this agreement, if the Cardmember should be absent from Sri Lanka formore than one month, the Cardmember shall leave clear and specific instructions to settle the Card account and shalladvise such instructions to the Bank's Card Centre, prior tohis/her departure.

#### 29 Amendments:

The Bank reserves the right to vary, amend and/or substitute anyterms of this agreement from time to time without prior notice. Anysuch amendment shall be deemed to be effective and binding on the Cardmember in accordance with the notice issued in terms of Section 31, below.

# 30 Warning Bulletins:

The Bank shall have absolute right and discretion to make reference of the Card in the warning bulletin in Sri Lanka or abroad notifying theservice establishment to seize the Card, without assigning any reasonwhatsoever.

## 31 Notices:

Any notice under this agreement, (including any revision thereof) and any notice relating to the Card Account, shall be provided in writing (through paper and/or electronic communication channels, including on the Bank's corporate website and/or www.americanexpress.lk and/or in any other manner deemed suitable by the Bank based on the nature of the communication. Any information or intimation relating to the Card Account statement or made a part of the statement shall alsodeem to be a notice under this agreement.

Notices provided in the aforementioned manner shall be effective as follows:

- if sent by post, two (02) days after posting;
- if sent by e-mail, short message service ("SMS") and/or other electronic form, on transmission (unless the Bank receives a delivery failurenotice, in which case it will be communicated in a different manner); and
- if made as public announcements in daily newspapers, posted at Bank branches, automatic teller machines or on the Bank'scorporate website and/or <a href="www.americanexpress.lk">www.americanexpress.lk</a> or in any other manner, would be effective at the time of publication or posting, or such other time that the Bank states in the communication;

Notice sent in the aforementioned manner shall be deemed sufficient and proper notice and shall be binding on the Cardmember.

The Cardmember shall notify the Bank without delay in writing of any changes in the Cardmember's name, contact details (including postal address, mobile phone number and e-mail address), and/or any other particulars registered with the Bank, by post, e-mail or through the use of Bank's digital channels.

If a Cardmember does not provide the Bank with updated contact information, the Cardmember shall bear any loss that may arise from not receiving notices. The Bank may suspend or stop sending notices if the Bank reasonably believes that the Cardmember is no longer reachable at the address/contactinformation last notified to the Bank. In such event, the Customer waives all requirements of notice under these terms and conditions.

The Cardmember must send or confirm any notice to the Bank byprepaid post to the following address:

## **32 Expenses of Enforcement:**

The basic Cardmember and each supplementary Cardmember shall be jointly and severally liable to indemnify the Bank in respect of any and all expenses incurred by the Bank in enforcing or attempting to enforce these terms and conditions including all legal fees and disbursements on a full indemnity basis.

## 33 Supplementary Cards:

The Bank at its sole discretion may provide the facility of asupplementary Card to the family members of the Cardmembers on such terms and conditions as decided by the Bank from time totime. The holder(s) of any supplementary Card(s) on the account and the Cardmember authorizing its issuance is jointly and severallyliable for all charges incurred by the use of Card(s). The facility of asupplementary Card will be dependent on the continuation of the basic Cardmember.

# 34 Application of Payments:

Any and all payments received by the Bank from or on behalf of the Cardmember may be applied or appropriated by the Bank in suchmanner and in such order as the Bank deems fit, notwithstanding any specific appropriation instruction by the Cardmember or any other person making the payment.

## 35 Authorizations and Indemnity for Telephone, Internet, Telex, Facsimile and E-mail Instructions:

- 35.1 The Cardmember authorizes the Bank to rely upon and actin accordance with any notice, instruction, demand or othercommunication, which may from time to time be, or purportto be given by telephone, internet, telex, facsimile ore-mail by the Cardmember or on his/her behalf, without anyinquiry on the Bank's part including, without prejudice to thegenerality of the foregoing, as to the authority or identity ofthe person giving or purporting to give the instructions andregardless the circumstances prevailing at the time of receiptof the instructions. The Cardmember will accept the Bank'sruling on time / date of receipt instructions as final.
- 35.2 The Bank shall be entitled to treat the instructions as fully authorized by and binding upon the Cardmember and the Bank shall be entitled to take such steps in connection with or in reliance upon the instructions as the Bank may consider appropriate, whether the Instruction is to pay money or otherwise to debit or credit any account, or relate to the disposition of any money or documents, or purports to bind the Cardmember to any agreement or other arrangement with the Bank or with any other person or to commit the Cardmember to any other type of transaction or arrangement whatsoever, regardless of the nature of the transaction or arrangement or the amount of money involved and notwithstanding any error, ambiguity, misunderstanding or lack of clarity in the terms of the Instructions.
- 35.3 In consideration of the Bank acting in accordance with the terms of this authorization and indemnity the Cardmember hereby irrevocably undertakes to indemnify the Bank and to keep the Bank indemnified against all losses, claims, actions, proceedings, demands, damages, costs and expenses incurred or sustained by the Bank of whatever nature and howsoever arising out of or in connection with the instructions.
- 35.4 The terms of this authorization and indemnity shall remain infull force and effect unless and until the Bank receives, andhas a reasonable time to act upon, notice of termination from the Cardmember, save that such termination will not release the Cardmember from any liability under this authorization and indemnity in respect of any act performed in accordance with the terms of this authorization and indemnity prior to the expiry of such time.

#### 36 Miscellaneous:

- 36.1 The Cardmember hereby authorizes the Bank to contacthis employer or any other source to obtain any furtherinformation that may be required regarding the Cardmember. The Cardmember agrees that the Bank is entitled to telephonically remind the Cardmember of the payments, due on a bill or leave a reminder message with the personreceiving the telephone call on behalf of the Cardmember. The Bank shall be under no obligation whatsoever to remind the Cardmember regarding dues payable on the Card whetherin writing or otherwise and the Bank exercising its option and right on the aforesaid shall not be called into question.
- The Cardmember hereby irrevocably authorizes the Bank toapproach his company or his banker to hold hisassets / monies against any outstanding balances on his Cardand to do all acts, deeds, and things which the Bank may deemfit in connection therewith. This Section 36.2 shall survive the termination of this agreement.
- None of the Bank's rights shall be deemed to have beenwaived by any act or conduct of the Bank, or by any neglect ordelay in exercising such rights, and every right shall continue full force and effect until specifically waived by the Bankin writing.
- 36.4 The Cardmember expressly recognizes and accepts that theBank shall be absolutely entitled and have full power andauthority to sell, transfer or assign any or all outstanding and dues of a Cardmember to any third party of the Bank's choiceand written intimation by the Bank to the Cardmember of

Any such action shall bind the Cardmember to accept such third party of such obligation to the Bank. Any cost in this behalf will be charged to the account of the Cardmember.

- 36.5 The Cardmember shall take cognizance of the fact that creditbalance, if any, in the Cardmember's account shall not attractany interest obligation on the part of the Bank whatsoever.
- Loyalty programmers, if any, available to the Cardmember by virtue of his/her Card membership will be governed byseparate terms and conditions as may be applicable for such programmes.
- 36.7 Service establishments may not honour the Card when suchService Establishments organize and conduct a discount orreduction sale in respect of their merchandise or service.
- 36.8 The Bank has the right to change this agreement at any timeand will notify the Cardmember of any changes in accordance with Section 31 above. The Bank shall be entitled to consider that the Cardmember has accepted the changes if the Cardmember continues to keep or use the Card afterreceipt of notice. If the Cardmember does not accept the changes, the Cardmember may terminate this agreement in accordance with the provisions stipulated in clause 7(Termination). The Cardmember shall continue to be liable and responsible forall fees and Charges made before such termination.

#### 37 Law and Jurisdiction:

This agreement will be governed by and construed in accordancewith the laws of Sri Lanka. This agreement will automatically standamended if law, government regulations or instructions issued by the Central Bank of Sri Lanka or any other statutory body, necessitates such amendments. The Card and Card account may be used only forvalid and lawful purposes. If a Cardmember uses, or allows someone else to use, the Card or the Card account for any other purpose, the Cardmember will be responsible for such use and may be required to reimburse the Bank or American Express all losses / expenses incurred as a result of such use.

## 38 Terms of Assignability:

The Cardmember hereby consents, both now and at any time in thefuture, to the assignment of the whole or any part of this agreementby the Bank to any American Express company, or any of its affiliated companies or designees (any "American Express Entity"), and agreesthat any such assignment shall become effective upon the date statedin any notice of assignment given to the Cardmember by Bank or byany "American Express Entity."
