1. E-Statement shall mean the credit card statement sent to the Cardmember via- e-mail relating to the Cardmember's credit card account.
2. In the event the Cardmember's application for e statements is accepted by the Bank an e-statement shall be sent to the Cardmember by the Bank on a monthly basis or at such other time intervals as may from time to time be determined by the Bank through the e-mail address notified to the Bank by the Cardmember or any person authorized by the Cardmember in writing to act on the Cardmember's behalf ("Authorized Person(s)). The Cardmember authorizes the Bank to accept and act on any instructions which may from time to time be sent to the Bank via telephone, facsimile or email by the Cardmember or the Authorized Person(s) regarding e-statements.
3. The Cardmember agrees that the Bank will not be liable for any losses which the Cardmember may suffer in the event the Bank acts on the instructions of any person other than that of the Cardmember or the Authorized Person(s) PROVIDED THAT the Bank acts in good faith believing such person(s) giving instructions to be the Cardmember or the Authorized Person(s).
4. The Cardmember further acknowledges and accepts that transmission of information through the internet/via e-mail cannot be guaranteed to be error free due to the inherent nature of such transmission and the Cardmember agrees that the Bank shall not be liable for such errors or for any loss or damage that maybe suffered or incurred by the Cardmember thereby
5. The Cardmember also acknowledges and agree that the Bank shall provide the Cardmember with a paper bank statement(s) in respect of the Cardmember's Account(s) only if the Cardmember makes a specific request therefore and on payment by the Cardmember of the relevant charges.
6. The Cardmember shall pay to the Bank on demand all monies, fees, charges and expenses required for or incidental to the provision to the Cardmember of the e-statement facility. Further the Bank is irrevocably authorized to settle such payments by debiting the Cardmember's Account(s) with the Bank.
7. The Cardmember undertakes to keep the Bank indemnified and saved harmless at all times from and against all actions, proceedings, claims, loss, damage, costs and expenses which may be brought or made against the Bank or suffered or incurred by the Bank and which shall have arisen either directly or indirectly out of or in connection with the Bank providing the Cardmember with e-statements and acting upon the Cardmember's instructions or the instructions of the Authorized Person(s)
8. Notwithstanding any provision herein contained, the Bank may at any time in its absolute discretion refuse to execute any of the Cardmember's instructions or the instructions of the Authorized Person(s) pertaining to the e statement facility without giving any reason and without being responsible for any loss or damage suffered by the Cardmember thereby.
9. The Cardmember may terminate the e statement facility by giving the Bank not less than 14 days prior notice in writing duly signed by the Cardmember.
10. The Bank may at any time in its absolute discretion withdraw or terminate the e statement facility without prior notice and without assigning any reason.
11. These terms and conditions shall be in addition to and not in derogation of the Cardmember terms and conditions which will continue to apply.
